Directions

1. Dilute 5 g - 10 g per 5 L of clean water depending on plant to be protected and disease to be controlled. (See label).
2. Apply as a protectant and/or at first sign of disease in spring, autumn and winter.
3. Spray foliage until run off occurs, making sure to cover leaves on both the upper and lower surfaces as complete coverage is required for effective control.
4. Then apply every 21 days thereafter.

Plant	Timing	Protectant Rate	Disease Treatment Rate
Controls Powdery Mildew on:			
Apples	From bud movement to harvest. Use after Dec may affect fruit finish.	5g per 5 Litres	10g per 5 Litres
Grapes	At bud swell & then at 14 day intervals as required.	7.5g per 5 Litres	15g per 5 Litres
Roses	At 14 day intervals.	10g per 5 Litres	15g per 5 Litres

Vegetables	At 14 day intervals during growing season.	5g per 5 Litres	15g per 5 Litres
Controls Rust on:			
Peaches, Plums, Nectarines	At fruit set & then at 21 day intervals until harvest.	5g per 5 Litres	10g per 5 Litres
Controls Moss, Lichens on:			
Roses, Fruit trees	Repeat as required	5g per 5 Litres	10g per 5 Litres

For measuring purposes 5g = 1 teaspoon

Powder Concentrate: 200 g

Active Ingredients

800 g/kg Sulphur in the form of a water dispersible granule

For Best Results

- Use as part of the winter preventative spraying programme.
- You can use Organic Super Sulphur to control the growth of lichen and moss on the trunk and bark of trees.

Caution

- Do not apply to apricot or pear trees. Do not use on Kidds Orange Red, Cox's Orange Pippin or Red Delicious apple variants.
- Wash treated crops before eating. No withholding period.
