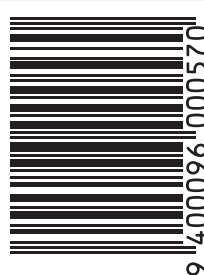

READ LABEL BEFORE USE

WARNING: Causes serious eye irritation. May cause allergic skin reaction. Harmful to aquatic life with long lasting effects. Avoid contact with eyes and skin. Wash hands and face thoroughly after use. Do NOT eat, drink, or smoke while using. Wear disposable gloves while using.

FIRST AID: This product is non-toxic to humans. Good hygiene should still be practiced. Wash any exposed skin with soap and water after use and before eating or smoking. If swallowed do not induce vomiting and give one or two glasses of water. If feeling unwell, contact the National Poisons Centre (0800 764 766). If in EYES, rinse cautiously with water for several minutes. Remove contact lenses if present and safe to do so, continue rinsing and seek medical advice if irritation persists.

SPILLAGE: Do not walk-through spilled material. Absorb spilt material using sand or soil, place in a plastic bag or suitable container for safe disposal. Minimise risk of product entering waterways, drains or stormwater. Seek advice from the SDS regarding disposal.

DIRECTIONS FOR USE: WEED WEAPON INVADE GEL may be directly applied to leaves or cut stems using a brush-head applicator bottle or by direct painting using a stiff short-bristled brush. If applying using a brush transfer the amount of product to be used in one session to a separate container to avoid cross-contamination of remaining product.

- Apply gel within 15 seconds of cutting weed.
- Do not brush vigorously, avoid foaming.
- Although WEED WEAPON INVADE GEL may be applied at any time of the year, it is best applied when plants are actively growing in spring or autumn
- Do NOT use if rain is expected within 12 hours.

WOODY SHRUBS AND WEEDS:

- Cut down below the lowest green growth and immediately apply the gel.
- Apply a thick layer to cover the cut surface by either tipping the applicator bottle upside down or by painting with a brush.

TREES (CUT STUMP):

- Cut tree as close as practical to ground level and immediately apply gel to freshly cut surface. Ensure complete cover.

IVY AND OTHER CREEPING WEEDS:

- Cut the weed back as much as possible, leaving approx. 20 leaves on the stem of each root system of the whole 'colony'.
- Apply a thick layer on the cut surface and both upper and lower surfaces of the leaves.

STORAGE: Store in original container tightly closed, away from foodstuffs, feed, and clothing. Storage must be generally in accordance with the New Zealand Standard for the Management of Agrichemicals (NZS8409).

CONTAINER DISPOSAL: Ensure container is completely empty. Triple rinse the empty container with water; dispose of washings by applying to an area of waste land. Recycle container where possible. Do NOT burn.

PRODUCT DISPOSAL: Ensure unwanted product is used by another operator strictly in accordance with label directions or dispose at an approved landfill or other approved facility.
