An organosilicone penetrant/surfactant that enhances the penetration and uptake of herbicides including Weed Weapon Glyphosate, and brushweed herbicides such as Weed Weapon Tough Brushweed and Weed Weapon Eliminate.

WARNING READ LABEL BEFORE USE

Harmful if swallowed. Causes serious eye irritation. Toxic to aquatic life with long-term effects. Avoid inhalation of mist or spray. Wear eye protection and disposable overalls or long-sleeved top, long trousers and closed in work shoes when using. Do not eat, drink, or smoke while using. Do not allow product to enter waterways or stormwater drains.

FIRST AID

Good hygiene should be practiced. Wash any exposed skin with soap and water after use and before eating, drinking, or smoking.

If in EYES, rinse cautiously for several minutes, remove contact lenses if present and safe to do so. Continue rinsing and seek medical advice or call the National-Poisons Centre (0800 764 766) if irritation persists.

SPILL AGE

Do not walk-through spilled material. Wear PPE recommended above. Stop leak when safe to do so. Bund area using soil or spill kit. Minimise risk of product entering waterways, drains or stormwater.

In case of a large spill, dike area and report to 0800 CHEMCALL, or 0800 243 622 and local or Regional Council.

In case of a transport emergency call 111, Police or Fire Brigade.

Tank mixes: Seek additional advice from the SDS or the label of the product to which WEED WEAPON PENETRANT OS has been added regarding disposal.

STORAGE

Store in original container tightly closed, away from foodstuffs, feed, and clothing.

Storage must be generally in accordance with the New Zealand Standard for the Management of Agrichemicals (NZS8409). Stores containing more than 1000-litres require secondary containment and an Emergency Response Plan.

CONTAINER DISPOSAL:

Ensure container is completely empty. Triple rinse the empty container with water; dispose of washings by adding to spray tank. Recycle through the Agrecovery programme. If this is not possible, bury in an approved landfill or other approved facility. Do NOT burn.

GENERAL INFORMATION

WEED WEAPON PENETRANT OS acts by increasing the contact area of the sprayed product of the leaf surface of the plant being sprayed. It will also act as a penetrant enhancing the speed of uptake of herbicide, particularly under adverse weather conditions.

DIRECTIONS FOR USE

Always refer to the manufacturers' instructions for those products to be used with WEED WEAPON PENETRANT OS or other organosilicone penetrants. Use those rates if they differ from the following.

MIXING:

Add WEED WEAPON PENETRANT OS to the spray tank after all herbicides and when the tank is almost full. Ensure there is sufficient agitation for complete mixing

COMPATABILITY:

Compatible with glyphosate, metsulfuron and most brushweed herbicides including triclopyr and picloram. Product is rainfast 30 minutes after application.
