## Directions

**Application Methods:** Kiwicare Deltamethrin 15 SC is a suspension concentrate formulation intended to be applied diluted, as a long term hard surface spray. A range of different types of application equipment may be used to apply it. Calibrate equipment to deliver the target rates indicated in the directions for use. If misting application equipment is used users should be aware of the greater potential for off-target drift with use of finer droplets. Protect non-target surfaces from spray drift.

Pressure spray equipment - for most pressure spray equipment the dilution rate will be 10-30 ml/L.

**Precautions:** Do not breath in the substance. Eye and face protection should be worn when using the substance. Avoid prolonged or repeated contact with skin. Wear gloves and wash exposed skin after use. Do not spray electric motors or switchgear with the water-based product. Avoid contact with food, food utensils or surfaces on which food is prepared. Before Use - Remove or cover all exposed foodstuffs, food equipment and preparation surfaces. Remove, or cover and turn off pumps, of all fish tanks. After Use - Thoroughly ventilate treated areas. Wash down all food contact surfaces.

**Application to Carpets:** Carpets are regarded as porous surfaces; however, non-porous surface rate should be adopted if possible. For short pile carpet, the 5 L of water/100m² should be sufficient. However, for long pile or shag carpet, the 10 L of water/100m² may be required to ensure effective penetration and application to all the carpet-pile. A small, inconspicuous area of carpet should be sprayed and allowed to dry to ensure that staining will not occur.
